How to Write a 30-Day Notice of Intent to Vacate to Your ...

Date the notice with the date you intend to give it to your landlord and calculate 30-days from that date as your move-out date. If you intend to mail the notice, add 5 days to your calculations because mail is presumed received on the fifth day after mailing.

If you provide notice through the mail, the minimum

notice requirement (e.g., 30 days) will be extended by three days. Therefore, in Oregon, if you deliver your 30-day notice through the mail, you will actually have to provide the landlord 33 days notice in order to account for the delivery time.
