While the landlord may choose to end your lease or raise your rent moving forward, state laws generally require a 30-day or 60-day notice before the tenant must vacate the premises.

For example, the standard is 30 days notice, but if your lease says 45, give notice 45 days before you move out. Don't forget to include the date of your letter, the date you'll be leaving your apartment and a forwarding address. If you're breaking your lease, there are some additional considerations.

Review Your Lease. Your lease likely contains information on how and when you should contact your landlord before terminating your tenancy. The lease may specify time frames for mailing off your letter, as well as the address to which you need to send your termination notice.

When you intend to vacate an apartment, give the landlord proper notice, either 30 days or 60 days in advance of moving out, depending on the status and the terms of your contract. There is no difference in the structure of a 30-versus 60-day notice; only the time frame is different. Review the terms of your lease, looking for the "notice" clause.

A. Ontario law requires a month-to-month tenant to give the landlord at least 60 days' written notice. The termination date stated in the notice must be the last day of the rental period or the lease term. Weekly and daily tenants are required to give 28 days' written notice.

When to give notice. If you pay your rent by the month or the year, or if you have any kind of fixed-term tenancy, you must give the notice to your landlord at least 60 days before your termination date. Exception for February: You can give a little less than 60 days' notice if February is one of the months in your notice period.

Most, but not all, landlord applications must be made

within 30 days of the termination date set out in the notice. However, there is no deadline for making an application to terminate a tenancy where the landlord has given the tenant a Notice to End a Tenancy Early for Non-Payment of Rent (Form N4).

after the tenant gives the landlord this notice if the tenancy is daily or weekly (the tenant pays rent daily or weekly). Also, the termination date must be the last day of the rental period. For example, if the tenant pays rent weekly each Monday, the termination date must be a Sunday.
