How Estate Administration Tax is calculated Probate fees are calculated on the value of the estate probated: \$5 per \$1,000 of estate assets up to \$50,000, and \$15 per \$1,000 of estate assets over \$50,000. Note that EAT is an 'asset' tax, not an income tax as is the norm in Canada. What must be included in estate assets When paying EAT, all assets owned by the deceased which form part of the Estate Administration Tax - Ministry of Finance

Estate administration tax, formerly known as probate fees, is charged on the total value of the deceased's estate. The total value of the estate is the value of all assets owned by the deceased at the time of death, including:
