How to Write a Letter of Notice to Your Landlord: 14 Steps

If you provide notice through the mail, the minimum notice requirement (e.g., 30 days) will be extended by three days. Therefore, in Oregon, if you deliver your 30-day notice through the mail, you will actually have to provide the landlord 33 days notice in order to account for the delivery time.

Tip: In your 30-day notice, state when you will be returning the keys and request a walk-through with the landlord if a security deposit is involved.

A 30-day time frame allows a landlord to make alternate arrangements to advertise the property and find new tenants. Landlords will appreciate a well-crafted and professional letter, which will allow you to terminate the tenancy amicably.

Sample 30 Day Notice to Landlord - Free Move Out Example

Once the landlord receives the tenant's 30-day notice, the tenant will still have to pay rent for the next 30 days unless the landlord is able to replace him with a new renter before that. Example: If you're a tenant and you send this notice on 18 May, you'll have to continue paying rent until 18 June.

You don't need a special form to give a 30-day notice to your landlord. A letter is sufficient. The content of the notice is most important. Address the letter to your landlord or person authorized by the lease to receive notices, such as the property manager. Date the letter and state your intention to move from your apartment and that you intend your letter to be your 30-day notice (or other required time period as specified in your lease). State the date by which you intend to move out of

The whole purpose of the notice is that you are giving the tenant 30 days to vacate the rental property. The verbiage of this notice can be simple and straightforward. This notice is to inform you that your tenancy will be terminated in THIRTY [30] days from the date of service of this notice.

If there s a disagreement between what we recommend and what your lease says, the lease wins. For example, the standard is 30 days notice, but if your lease says 45, give notice 45 days before you move out. Don t forget to include the date of your letter, the date you ll be leaving your apartment and a forwarding address.
