[Landlord's Five Day Notice INSTRUCTIONS](#) Prepare the Five Day Notice in duplicate; keep the original and give the copy to the tenant. Do not serve the five day notice on the day the rent is due. Wait until the rent is LATE (if the rent is due on the first of the month, you can serve on the second). To win a money judgment, you or your agent must serve the Notice personally. A 5 day notice means that the tenant is entitled to 5 full days to make payment in full of the past due rent. That means if you serve the notice on the 15th of the month, the tenant gets the 16th, 17th, 18th, 19th, and until midnight on the 20th; you cannot file the lawsuit until the 21st. Don't make the mistake of filing the complaint on the 5th day. If you do, your lawsuit will be

the entire payment is made on or before the expiration of five days after the service of this notice, your lease of the above rental premises will be terminated immediately.

The Virginia five (5) day notice to pay or quit is used when a tenant has failed to pay rent. The landlord must serve a written notice on the tenant and allow them five (5) days to pay the full past-due amount before filing an eviction lawsuit against them.

By the laws of Arizona, the tenant has an additional 5 days to pay rent when the notice is sent by mail, making it a 10-day notice. Do
