What do federal estate tax laws have to do with North Carolina estate taxes? Prior to January 1, 2005, North Carolina did collect a separate estate tax at the state level, called a "pick-up tax," that was equal to a portion of the overall federal estate tax bill.

The state exemption amount was tied to the federal one, which means that for deaths in 2012, estates with a total value of up to \$5.12 million were exempt from both state and federal estate taxes, but if an estate went over that amount a North Carolina estate might owe both taxes.
